From the exec's chair

Our members at Child and Family Services recently sat down with the Billings Gazette and aired some of the concerns they have this legislative session. With the Department of Public Health and Human Services looking at some serious cuts to an already understaffed and overworked division of DPHHS, the proposed \$93 million would result in the loss of about \$1 million to the CFS division impacting their ability to fill vacant positions. Governor Bullock addressed the issues faced by CFS in his State of the State address urging the legislature to not tie the hands of those who serve on the frontlines of keeping Montana kids safe. While this is certainly of concern, I want to caution everyone that it is still very early in the session and a lot can happen.

I attended the MEA-MFT board meeting January 27-28. This is the third MEA-MFT board meeting I have attended since our unions passed resolutions last year to explore the potential of merger. There is still a lot of work to do on this front but the meetings have been informative and the MEA-MFT board has made me feel extremely welcome and part off the team.

Legislative watch list

Representative Mary Ann Dunwell (HD 84-D) is introducing HB 341, generally revise state travel and per diem laws, to the House State Administration Committee on February 7. Representative Dunwell has asked that we support her bill with emails to committee members and those who are able to testify in person at the hearing. We realize that per diem does not impact all state employees but we also know that a significant number of MPEA and MEA-MFT members are negatively impacted. Considering that the per diem for state employees has not been increased in 20 years, it might be time to bump in-state and out-of-state per diem just a bit. You can use the links below to weigh in on the issue.

Governor Bullock announced that he exercised his right to offer an amendatory veto to HB 1 – designated to give legislators more money writing "I cannot in good faith accept a bill that allows one branch of government a free pass while everyone else pulls their weight. Montanans deserve better." MPEA applauds Governor Bullock's actions on behalf of the thousands of executive branch state employees we represent.
